Layaway for Jewelry, Watches & Custom Jewelry & Grill Order Contract

KUSH GRILLZ CUSTOM GRILLZ & JEWELRY CO. HAS DEVELOPED ITS LAYAWAY POLICY WITH OUR CUSTOMER IN MIND.

Payments must be made regularly, as scheduled, and must be received by Kush Grillz Custom Grillz & Jewelry Co., on or before the day they are due. Once payment has been made in full, your Layaway item will be shipped to you within two business days, or will be available for pick up, for Custom Grill & Jewelry Orders process will begin on your Custom Jewelry/Grill process.

LAYAWAY POLICY

- Layaways are good for 90 days and require a 30% down payment.
- Jewelry Purchase: If you change your mind within the first seven days following the date a jewelry item is put into layaway, you are entitled to receive a refund in the amount of the down payment.
- If you change your mind after seven days following the date a jewelry item is put into layaway, you will be given an in-store credit for any monies paid.
- Our 90 day layaway plan require a 30% down payment and subsequent payment of 30% after 30 days. The balance is then due at the end of 90 days.
- Layaway payments are non refundable and no credit/refund will be issued upon failure to complete payments.
- Hard good Purchase: If, at any time during the 90 day layaway period, you change your mind regarding a layaway purchase, you will not receive a cash refund, but you will be given an in-store credit for the amount of monies paid.
- If you do not complete payment of an item within the 90-day layaway period, you can request an in-store credit within 120 days of the original date of the layaway. After 120 days, the funds are forfeited.

Most Debit/Credit cards accepted, we process your Layaway payments via [Paypal](#), SQUARE, CASH App, or direct bank transfer. We also accept cash & money orders for Layaway payments.
